# **CONSEQUENCES OF BLOCKED GUTTERING**

# INVALIDATING INSURANCE

Many commercial properties insurance require you to maintain your property in the event of water damage and fire hazards. If you do not maintain your commercial property this could result in your insurance being void.

# **DAMAGE TO FOUNDATIONS**

Damage to foundations can occur when a blocked drain overflows during heavy rainfall. The water can pool at the base of the building and cause damage to the foundations. This can, over time, weaken the structure of the premises and has been known to cause localised collapse of the building.

# **LEAKING ROOFS**

Blocked gutters are the root cause of a large proportion of leaking roofs. Blocked gutters can cause water to pool on the roof and over time, the pooled water will seep through. This obviously means repairing the roof but, usually, requires repairs to inside walls and flooring as well.

# **INSECT INFESTATIONS**

This typically occurs when debris build up in a gutter becomes an ideal breeding ground for insects if the gutter is not regularly cleared. Insects are attracted by the damp conditions and will become a problem if not removed.

Blocked gutters are particularly attractive to termites which can have quite serious repercussions if they infest the whole building. Wasp nests are also an issue which often requires expensive, professional removal.

### **BROKEN GUTTERS**

Debris building up in a gutter can add significant weight to the gutter itself. When it rains, leaves and other debris will absorb the water and add immeasurably to the overall weight – this will in turn, eventually pull the gutter, and often it's fixings from the wall.

# HOW OFTEN SHOULD GUTTERS BE CLEANED?

To actually remove debris from the gutter things have moved on from long arms and manual strength. We use ground based vacuum systems to remove all the material – this has the added benefit of ensuring all the material is automatically removed from site by us rather than having to be swept and bagged up manually.
